2022 PROGRAM SERVICE ACCOMPLISHMENTS

At PRASAD Chikitsa, India, we continued our efforts to improve the quality of life while empowering economic improvement for long-term sustainability. The Mobile Hospital has expanded services to 21 remote villages and provided 7,968 medical visits. The Anukampaa Health Center completed 24,500 medical visits.

We have expanded the Nutrition Program, increasing the number of nutritional servings to 54,000+, benefiting more than 900 malnourished infants and pregnant mothers.

PRASAD Chikitsa has distributed 16,860 fruit and shade tree saplings, helping to improve food security and restore the environment.

PRASAD Children's Dental Health Program, U.S., continues improving children's dental health by delivering comprehensive dental services. We have provided dental health education and services to 2,000 children, performed 3,322 dental procedures, and completed 830 dental visits.

At PRASAD de Mexico, our dedicated volunteer team in Mexico organized two successful eye camps, at which 349 people received free surgery.






OPERATING REVENUES 2022
